This document aims to formalize between both parties any agreement made for the rental of items.

### PRICE AND RESERVATION

To confirm the reservation, 100% (one hundred percent) of the rental amount must be paid in CASH.  
In case of cancellation, the client must provide at least 10 (ten) days' prior notice.  
In case of cancellation without prior notice within the stipulated period, the amount paid as a reservation will not be refunded.

### PAYMENT AND SECURITY DEPOSIT

Payments related to the reservation must be made as agreed between the parties.  
The security deposit must be paid exclusively in **CASH** at the time of kit pickup.

#### **IMPORTANT**

If the security deposit amount is not presented in CASH at the time of pickup, the kit will not be released, without exception.  
Payment of the security deposit via bank transfer, card, or any other electronic method will not be accepted, since the amount is fully refunded in cash upon return of the items (provided they are in perfect condition and returned within the agreed timeframe).  
The amount will be refunded at the time of return, provided the items are in perfect condition and within the agreed deadline.  
In case of damage, breakage, loss, or missing items, the corresponding amount will be deducted from the security deposit.

### RETURN AND DELAY

The items must be returned on the previously agreed date and time.

#### **IMPORTANT CLAUSE :**

In the event of a 1 (one) day delay in returning the kit, the client will automatically lose the right to a full refund of the security deposit, regardless of the condition of the items, as the delay compromises the company's operational organization and future scheduled rentals.

### ON-SITE SETUP (LARGE DECORATIONS)

For large-scale decorations, including balloon arches and larger structures, setup may be carried out at the event location.  
In this case, an additional setup and transportation fee will be charged, defined according to the event address and subject to schedule availability.

### ITEM PICKUP

Items must be picked up at BIG FESTA.

Transportation, setup (when not contracted separately), dismantling, and care during the rental period are entirely under client's responsibility.

By signing this agreement, the client declares that all items are received in perfect condition.
